

# Michael Elston Honored with NSSAR 2019 Minuteman Award

I have the distinct honor and pleasure to inform the Compatriots of the George Washington Chapter that Mike Elston was nominated and selected to receive a 2019 National Society, Sons of the American Revolution (NSSAR) Minuteman Award. The Minuteman Medal is the highest award presented to a Compatriot for active and distinguished service rendered to the National Society. During the March 2019 NSSAR Spring Leadership Meeting in Louisville, the Minuteman Committee, with committee members appointed by the NSSAR President General, announced the names of the six Compatriots selected for the 2019 Minuteman Class, with Mike Elston being one of the six Compatriots so honored. Being selected to receive a Minuteman Award represents a tremendous personal honor for Mike, the George Washington Chapter and the Virginia Society. Congratulations Mike, from all of your fellow George Washington Chapter compatriots for this well-earned and deserved recognition by the National Society.

On March 2nd, 17 compatriots from SAR Chapter's across Northern Virginia, and a few outside the metro area, met at Mt. Vernon High School to participate as judges in the Virginia History Day, District V event. This was the single largest turnout of SAR compatriots ever in support to a VA History Day event. From the George Washington Chapter four compatriots participated as judges - Hank Foresman, Rich Sherman, David Kuhnsman and Dave Thomas.

The March 9th George Washington Chapter meeting was enjoyable and diverse. We welcomed 4 new Compatriots in to the Chapter--Adam Kincaid, Lawrence Robertson, Doug Smith and Houston Smith, and look forward to their future participation in the Chapter. As a result of performing an incredible 400 hours of volunteer service rendered to NSSAR in 2018, Compatriot Jamie Callender was presented with six NSSAR Lafayette Service Medal Oak Leaf Clusters. It should be noted that Jamie is the only Virginia Society compatriot to ever be awarded the Lafayette Service Medal for extensive services volunteered to NSSAR. Compatriot Don Reynolds received a NSSAR Flag Certificate for consistently flying Old Glory in front of his home. The certificate was presented by former Chapter President Paul Walden. Further, Compatriot Richard Rogers received his commission and rank insignia in the VASSAR First Virginia Regiment from Vice President Jay Henn. First Virginia, Captain Rogers was honored by the Virginia Society for his contributions to the charitable funds of the Virginia Society, in particular the "Washington's Friends and Foes" fund. Additionally, Chapter Registrar Richard Sherman was awarded the Virginia State Service Medal at the 2019 VASSAR Annual Meeting in recognition of his many years of successful service as Chairman of the VASSAR Knight Essay Competition Committee. The award certificate was presented by Vice President, Jay Henn.

The guest speaker, National Park Historian, Mr. Mark Maloy delivered a very interesting talk based on his book "Victory or Death, The Battles of Trenton and Princeton December 25, 1776 - January 3, 1777". Mr. Maloy presented thoughts on military strategies and the history surrounding the two battles, as well as the significance of the two victories and what it meant to the survival of the young United States.

# George Washington Chapter 65th Anniversary

This April the George Washington Chapter celebrates 65 years since being chartered into the Virginia Society, Sons of the American Revolution in April 1954. There were 14 founding members that had a vision to serve the community, represent the ideals of the SAR and to honor their Revolutionary War patriot ancestors. The first Chapter President, Robert V. H. Duncan, knew then they had to grow as a Chapter, establishing a path and remaining committed to the fundamental goals of the Chapter, the Virginia Society and the larger SAR to further interest new members, to be more engaged in performing local community service, and to actively honor our Revolutionary War patriots and present day veterans.

If the original 14 Chapter members of 65 years ago would magically appear and have the ability to see and experience the George Washington Chapter of 2019, I believe they would be amazed, proud and honored to see the matured results of the Chapter they set in motion years ago.

# **April Speaker**

In line with our Chapter's efforts to increase our interactions with other SAR, DAR, and C.A.R. Chapters and Societies, as our April speaker we welcome Holly Lynne McKinley Schmidt, who will be sharing her many experiences with the "ins and outs" of SAR/DAR/C.A.R. cooperation.

Holly Lynne is winding down a three-year term as Virginia DAR State Historian where she completed the task of digitizing and syncing the Virginia State Society records with National Headquarters records, and found several ways to maintain the history of Virginia DAR for years to come. She is also serving as the National Vice Chair of DAR Leadership Training–Webinars; is an Honorary Chapter Regent; current Chapter Parliamentarian; and was honored as the 2015 National Outstanding Junior. Her DAR service also includes multiple State and Chapter Chairmanships, many clublevel offices, and 18 years of paging experience.

Holly Lynne is also a Senior National Honorary Vice President of the National Society Children of the American Revolution and is the Senior National Chairman for the Information Technology Committee. She has previously served on the national level as Senior National Recording Secretary, Senior National Registrar, and Senior National Librarian. A member of the C.A.R. Alumni Foundation, Holly Lynne is a C.A.R. Life Promoter and both an Honorary State President and Honorary Senior State President of the Virginia Society C.A.R.

As a proud SAR wife and daughter, she has served the SAR in many support roles over the last 20 years. She is a recipient of the Silver and Bronze SAR-C.A.R. Medal of Appreciation, Molly Pitcher, SAR Ladies' Service, Silver and Bronze Good Citizenship, Daughters of Liberty, and Gold SAR Medal of Appreciation Medals.

She is a Sapphire Patron of the Rumbaugh SAR Orations contest, where her father, Larry McKinley, provided nearly 25 years of dedicated service at the National level.



Beyond lineage organizations, she is the English Handbell Choir director for two choirs at her church and serves on the Worship committee. Holly Lynne is an information security policy and cyber defense consultant for Booz Allen Hamilton in Northern Virginia, currently serving the Intelligence Community market. She is a bachelor's graduate of Virginia Tech and holds Masters degrees from Johns Hopkins University and West Virginia University in IT and Legal Studies.

### In Memoriam--

Compatriot Rodney Hayes Lovdal, from Falls Church, VA, was born in Superior, Wisconsin and raised in Minnesota and Indiana. In 1948 he enlisted in the US Navy and spent his enlisted service in the Submarine Force. Rod was commissioned in the Regular Navy in 1956 and served on several ships, overseas assignments, and shore stations until his retirement in 1975. After Navy retirement he worked in the private sector and the Federal Government. Compatriot Rod Lovdals' membership in the SAR is based on his bloodline descent from Patriot Moses Hayes. During the Revolution Moses Hayes provided supplies and waggonage in Augusta County, Virginia.

# Revolutionary War Patriots of the George Washington Chapter

During 2019 the Chapter is placing more focus on honoring Revolutionary War patriots, and there's no better way to honor these men than to read the Patriot Biographies submitted by Chapter Members. Take a moment to read the Patriot Biographies of Major William Lewis, Private Zerubbabel Hunnewell and Private Robert Hendry, thus honoring their memories and service. Major William Lewis (1750-1812) was born in Ireland about 1750. He married Mary John on 10 Jun 1770 probably in Loudoun County, Virginia. During the Revolution, Patriot Lewis served as a Captain under Brigadier General John Peter Gabriel Muhlenberg and fought at Brandywine Bridge (11 Sep 1777) and Germantown (8 Oct 1777). He was at Valley Forge (Winter 1777-78) and fought as part of General Greene's Division at Monmouth, New Jersey (July 1778) and later the same year with General Putnam's Division on the North River. He was at Middlebrook, New Jersey (Winter 1778-79). He was promoted to Major on 12 May 1779 and attached to the 10th Virginia Regiment under Colonels Edward Stevens, John Green and William Davies. In the latter part of the year, he was attached to the command of General Benjamin Lincoln at Charleston. After a siege of about 6 weeks, Lincoln surrendered to Sir Henry Clinton and William Lewis became a prisoner of war. Clinton had about 9,000 men while Lincoln's garrison did not exceed 2,500. Patriot William Lewis remained a POW until he was released on May 1, 1783. As a Revolutionary War officer, he was awarded 1,100 acres at the Waxsaw Settlement, now Union County, South Carolina. He then moved to Washington Dist. in the NW part of the

state, later known as Pendleton County He settled near the town of Pendleton. He died before 11 May 1812 in White County, Tennessee.

Patriot Zerubbabel Hunnewell (1716-1803) was born in Scarborough, Cumberland County, Maine on 15 Apr 1716 to Roger Hunnewell (1676-1720) and Mary Moore (1680-1750). He married Hannah (Cobb) Swett (1712-1791) in Portland, Cumberland County, Maine on 7 Feb 1754. During the Revolution he provided patriot service by serving as a member of the Committee of Correspondence and Safety, Windham, Massachusetts, in 1776, 1777, 1778, 1780 and 1783. He died in Windham, Cumberland County, Maine on 23 Aug 1803 and was buried at the Old Anderson-Hunnewell Cemetery, Windham, Maine.

Private Robert Hendry (1752 1830) was born March 17, 1752, on the island of Arran, Scotland. He came to America about 1770 with his brothers James and William and settled in New Hanover County, NC. In 1778 he married Ann Lee of the Black River settlement. During the Revolution he served as a Soldier while living in New Hanover County. He is believed to have served under Light-Horse Harry Lee and been present at Cornwallis's surrender at Yorktown. He was commissioned as Justice of the Peace of Liberty County in 1802, serving periodically until 1824. Based on his service during the Revolution he participated in the 1827 Georgia Land Lottery. He is buried at Ft. Stewart in Liberty County, Georgia.

Vernon, NSSAR Wreath Laying Ceremony at the Tomb of the Unknowns at Arlington National Cemetery and the Veterans Day Wreath Laying Ceremony at Mt. Vernon. These events were not organized and do not occur by themselves, rather it is through the vision, dedication, innovation and hard work by many of our Chapter compatriots, over 65 years, that have kept these unique traditions alive over many decades. These core events represent our commitment to our forefathers, our commitment to community, our commitment to the ideals of the SAR and represent the very fabric of the George Washington Chapter itself.

The George Washington Chapter is proud to be involved with supporting our local youth, offering programs that require a knowledge of the American Revolution--Joseph H. Rumbaugh Historical Oration Contest, Knight Essay Contest, Sergeant Adams Brochure Contest, Eagle Scout Recognition, JROTC Recognition Program and volunteering as judges for Virginia History Day. Without exception, the George Washington Chapter's record in recognizing and presenting Public Safety Awards to Law Enforcement, EMS and Fire & Rescue officers and personnel is outstanding. Last year, 59 medals and certificates were awarded to men and women in the City of Alexandria, Fairfax County, Arlington County and Prince William County departments. Most notably recognition was extended to the Alexandria Police Officers and EMS personnel who responded to the Congressional Ballfield shooting in June of 2017. These men and women are the hero's and patriots of today. As performed over the past 65 years, the Chapter will continue to recognize and extend Public Safety Awards to our hero's and patriots in the years to come.

As I thought more about the past 65 years, it was obvious to me our Chapter membership was the most important thing to recognize and celebrate. Chapter members represent the heart of the Chapter, and through participation the Chapter has achieved success year-afteryear. Over 65 years, the George Washington Chapter has had 57 different Presidents (some served twice); 11 became VASSAR Presidents; 3 NSSAR President Generals who are dual members; 4 Chapter Compatriots have received the highest form of recognition the National Society can bestow--the Minuteman Award; and our members have consistently performed at the highest levels of the Virginia Society and the National Society making a true and positive difference now and over the past 65 years. Without the faithful commitment and dedication of its hundreds of members the George Washington Chapter wouldn't be what it is today--a leader in the National Society.

# **Deputy Juarez Receives VASSAR Award**



On March 5, John Blair of the George Washington Chapter of the Sons of the American Revolution presented Deputy Myrna Juarez with an award from the Virginia State Society of the Sons of the American Revolution. Deputy Juarez received the award for her efforts and response, while off duty, to a crash on I-95.

Sheriff Dana Lawhorne joined Mr. Blair, who serves as the Public Safety Awards Chair for the GW Chapter, as he presented Deputy Juarez with the award at a Sheriff's

Office staff meeting. Several of Deputy Juarez's colleagues and commanders were also present and congratulated her on her recognition.

On the morning of June 30, 2017, Deputy Juarez was driving to work when she witnessed a motor vehicle crash along I-95 near Woodbridge. She saw a car overturn and then saw a person on the road. She immediately pulled into the emergency lane and ran to the crash scene.

No other first responders were present and she could see that the victim, a man who had been ejected from the car, had a bad head injury and another passenger from the same vehicle was trying to help him. Deputy Juarez called 911 and then directed the passenger to keep pressure on the victim's head wound until medics arrived. She instructed two other passengers to try to keep traffic moving so that police and medics would not be delayed in reaching the crash scene.



She checked again on the victim, grabbing his hand and telling him to squeeze hers. The victim was unresponsive and when Virginia State Police arrived, Deputy Juarez informed the trooper that the victim was not alert. The trooper gave Deputy Juarez gloves, and she also applied pressure to the victim's head injury. Once EMS arrived on the scene, medics took over treatment and had the victim airlifted to Inova Fairfax Hospital. Despite the efforts of physicians, medics, Deputy Juarez and a passenger, the victim did not survive.

Even though she was off-duty, Deputy Juarez never hesitated to take action and did her best to help a critically-injured crash victim.
